### Farm Bill Still Stalled

The 2012 Farm Bill, which was held up in Congress before the November elections, is back on center stage. The Democratic-led Senate has already passed its version of the farm bill, but Republican House leaders stopped action on the bill before the election, saying there weren't enough votes. Senate Agriculture Chairwoman Debbie Stabenow (D-Mich.) has stated that she is prepared to merge the House and Senate versions, but Doug Heye, a spokesman for House Majority Leader Eric Cantor, said no decisions have been made on how to move the farm bill.

### Funding for Research Faces Big Cuts

Continuing funding cuts at the state and federal level are threatening the research capacity for almonds and other California crops. Reduced federal spending for the USDA Agricultural Research Service last year eliminated funds for some 120 ARS scientists and staff overnight; 10 research stations and programs closed in 2011. ## USDA Seeks Suggestions for Projects

The U.S. Department of Agriculture's Animal and Plant Health Inspection Service (APHIS) is inviting stakeholders to submit suggestions for fiscal year 2013 projects to implement Section 10201 of the 2008 Farm Bill. This Section authorizes the Secretary of Agriculture to make \$50 million available for 2013 projects in one of six goal areas: enhancing plant pest/disease analysis and survey; targeting domestic inspection activities at vulnerable points in the safeguarding continuum; enhancing and strengthening pest identification and technology; safeguarding nursery production; enhancing mitigation capabilities; and conducting outreach and education about these issues. ## Latest Draft of Discussion Paper Reflects IPM Voice Recommendations

The Association of Public and Land-Grant Universities Board on Agriculture Assembly, Budget and Advocacy Committee appointed an IPM Working Group in May 2012 to review the Integrated Crop Protection Program consolidation. The Working Group has drafted a discussion paper containing recommendations that will guide the budget authorization process by addressing the erosion of previous funding for IPM from the National Institute for Food and Agriculture.

The [November 7th revision](#) included IPM Voice's suggestions regarding a graph on the first page clarifying funding losses and gains, as well as needs for the future.

## Collins Queries NIFA on Consolidation

IPM Voice, in cooperation with Jim Dill the Maine IPM coordinator, recently met with Senator Collins' office to seek her involvement in IPM issues. In response, Senator Collins -- a key member of the Senate Appropriations Committee -- submitted a question to NIFA about consolidation and its effect on IPM programs. The response did not necessarily break new ground, but the step that she took in submitting the question signals to NIFA that there is support on Capitol Hill for IPM.
